



Refer ANU Earn TERMS AND CONDITIONS

1. Information on how to enter and the payment method form part of these Terms and Conditions. The Promoter is Australian National University ABN 52 234 063 906. Participation in this Promotion is conditional on acceptance of these Terms and Conditions. This Promotion is not valid in conjunction with any other ANU offers.
2. For the purposes of this Promotion, an ANU Residence is a purpose-built student accommodation location managed by the Promoter (each an “ANU Residence”).
3. Entry into the Promotion is open to Australian citizens and residents and international students, aged 18 years or over (“Eligible Entrant”).
4. Employees (and their immediate families) of the Promoter are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister.
5. Entries into the promotion opens on 16/02/2024 and closes 11:59pm AEDST on 25/02/2024 (“Promotional Period”) or as otherwise extended at the discretion of the Promoter.
6. To be eligible to enter and receive a payment in reward of a successful referral, Eligible Entrants must, during the Promotional Period, successfully refer a friend who is assessed and accepted by ANU to reside at an ANU Residence, and does not hold a current ANU (including Affiliates) Occupancy Agreement. Eligible Entrants must enter their details along with the details of the friend that they wish to refer (including their full name and email address) and submit the fully completed referral. Eligible Entrants submitting a referral agree and acknowledge that they have their referred friend’s permission and consent to refer them for the purposes of this Promotion and agree to these Terms and Conditions. Entrants cannot refer themselves. Banking details of the Entrant will be collected for payments only upon successful referral(s). Payment will be made to Entrant no later than 30 business days of a referral being accepted by ANU. Referred student who successfully receives a place at an ANU Residence receives a credit of \$1000 to StarRez account upon acceptance.
7. Multiple referrals are permitted but an individual can only be referred once. If a person is referred multiple times, only the first Eligible Entrant to refer them will be awarded an entry into the Promotion.
8. The Promoter reserves the right, at any time, to verify the validity of entries, Eligible Entrants (including an Eligible Entrant’s identity, age) and their referred friends. The Promoter reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the Promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.

9. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the Promotion, as appropriate.

10. Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the ACT ("Non-Excludable Guarantees"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion.

11. The Promoter collects personal information in order to conduct the Promotion and may, for this purpose, disclose such personal information to third parties, including but not limited to agents, contractors, service providers, and, as required, to Australian regulatory authorities. Entry is conditional on providing this personal information.
